Summary of experience

Strategic planning Was the lead consultant in preparation of the Meat Industry Strategic Plan to 2001 for the entire Australian meat industry – the first time such a strategic plan has been produced. The project involved extensive interactions, discussion and analysis with all parts of the meat industry covering marketing, processing and production. As a result of the study, several major innovative decisions have been taken by the industry, including implementation of a grading system for beef and lamb.

The report recommended corporatisation of the Australian Government Health Service and opening up of competition to private suppliers. These recommendations have been largely adopted.

The findings of the study showed tourism could make a significant contribution to Australia's prosperity, provided the right policy environment is in place.
